Open setback area is not checked, it shall be checked by the concern building sanctioning authority. This department has no objection for said proposal subject to the compliance of the following fire safety recommendations:-

- 1. Access to building: The building is located on 18 meter wide road and approachable through 06 meter wide two gates. The entrance gate shall fold back against the compound wall of the premises thus leaving the exterior access in the plot. The archway, if any, shall not be at a height less than 5 meters. Clear cut 06 meter wide fire tender movement road with 09 meter turning circle all around the building capable of taking the load of fire engine weighing up to 45 tonnes shall be provided for free movement of fire engine as per clause 8.2 of UBBL 2016.
- 2. Number, width, Type and arrangement of exits: 04 staircases of 1.5 meter wide each are provided in the building from basement floor to ground floor and then 02 staircases of 1.5 meter wide each and 01 staircase of 2 meter wide from ground floor to terrace level and these meet the requirements as per UBBI-2016. One inspection ladder is also proposed to reach the overhead water storage tank for inspection.
